ABOUT NUSRL

It is with great pride that we introduce the National University of Study and Research in Law (NUSRL), Ranchi, established under the National University of Study and Research in Law, Ranchi Act, 2010 by the Government of Jharkhand. The Rector of the University is the Hon'ble Governor of Jharkhand, Shri Santosh Kumar Gangwar. The Hon'ble Chief Justice of the High Court of Jharkhand, Justice Tarlok Singh Chauhan, serves as the Chancellor, while the Hon'ble Justice Surya Kant, Judge of the Supreme Court of India, is the Visitor of the University.

NUSRL offers undergraduate, postgraduate, and doctoral programmes in law, including B.A. LL.B. (Hons.), B.B.A. LL.B. (Hons.), LL.M., and Ph.D., with a strong emphasis on academic excellence, professional engagement, and interdisciplinary research. The University is committed to fostering meaningful collaborations with the legal profession, including law firms, advocates, and regulatory bodies. Further, it hosts several specialized research centres, among which is the Chair for Consumer Research and Policy, dedicated to advancing scholarship and policy discourse in the field of consumer protection and law.

ABOUT THE CHAIR

The Chair on Consumer Research and Policy (CCRP) was established at NUSRL, Ranchi in October 2024 by the Ministry of Consumer Affairs, Food & Public Distribution Department of Consumer Affairs, Government of India, New Delhi, to promote research, teaching and training in Consumer law. The Chair acts as a "Think Tank" for the research and policy related issues on consumer law and also develop consumer affairs as a distinct subject of study both at Under Graduate & Post Graduate levels. The Chair aims at protecting the rights and interests of the consumers through consumer awareness, timely and effective grievance redressal, involvement of various stakeholders, etc. It aims at empowering consumers through awareness programmes to enhance consumer protection and safety against unfair trade practices, effective redressal mechanisms, etc. The chair promotes seminars, workshops, and training programs, empirical research, etc., on present consumer law issues.

ELIGIBILITY

1) Internship is open to students from recognized law and other institutions and universities.

2) Students pursuing the following courses can apply:

- a. Second and third year of the Bachelor's degree in Law (3-year course after graduation) or
- b. Second year onwards in the case of the integrated five-year course in Law.
- c. LLM students.
- d. Students from other academic backgrounds apart from law (i.e students from NIT and the National Institute of Design).

PROCESS

The selection of interns shall be conducted through a three-tiered process:

Stage I – Curriculum Vitae (CV) Evaluation: Applications shall be screened on the basis of academic credentials, research aptitude, skills, and overall suitability as reflected in the submitted CV.

Stage II – Work / Draft Evaluation: Shortlisted candidates from Stage I shall be required to submit samples of their work, drafting exercises, research papers, designing portfolios, or any other work as may be prescribed by the Chair. Evaluation at this stage shall be based on originality, analytical ability, relevance, and quality of work.

Stage III – Interview: Candidates shortlisted after the work evaluation shall be called for an interview, which may be conducted online or offline, at the discretion of the Chair. The interview shall assess the candidate's subject knowledge, research interest, communication skills, and suitability for the internship. The decision of the Chair regarding selection at each stage shall be final and binding.

- Applicants are required to provide their basic academic and contact details and upload an updated Curriculum Vitae (CV).
- Please ensure that all information furnished is accurate and credible.
- Incomplete applications or those submitted without a CV will not be taken into consideration.
- Once the CV is accepted, applicants are requested to provide the sample of their works, their designing portfolio and an essay on how they can contribute to the Chair, accordingly.
- The internship may be undertaken in either online or offline mode, depending on the preference indicated by the applicant and the discretion of the Chair.
- Applicants are advised to carefully review the eligibility criteria and deadlines before submission. Once accepted for the internship, applicants must send via email - ccrp@nusrlranchi.ac.in : -

A recommendation from the competent authority of the academic institution where the candidate is pursuing their studies. Applications without recommendations will not be entertained (format attached as Annexure - A and an undertaking as mentioned in Annexure – B.
