NOTIFICATION

Subject: Engagement of Legal Research Associates (LRAs) in the Appellate Tribunal, New Delhi on contract basis.

Applications are invited from Indian Nationals to work as Legal Research Associate (LRA) in Appellate Tribunal (SAFEMA) purely on contract basis possessing the following essential qualifications: -

- (i) Law Graduates, fresh or experienced who have passed final year L.L.B examination with a minimum aggregate of 50% marks from a recognized university.
- (ii) The candidate must be enrolled with Bar Council in India.
- (iii) The age of the candidate shall not be above 30 years as on last date of receipt of applications, i.e. 24.06.2026.
- (iv) The candidate must be well -versed in computer operation including research and retrieval of desired information using various search engines and Legal database such as Manupatra, SCC Online etc.
- (v) LRA should be of absolute integrity, honesty and good moral character for which he/she will submit certificate of two responsible persons/gazetted officers at the time of joining. LRA should not be involved in any criminal case whether convicted or in which criminal trial is pending.

2. Candidates will be selected on the basis of merit, subject to fulfillment of the required eligibility conditions and the terms and conditions mentioned in this notification. The Appellate Tribunal reserves the right to cancel the selection process or not to select any candidate without assigning any reason. No correspondence or request from applicants in this regard shall be entertained.



3. **Remuneration:** A consolidated remuneration of Rs. 50,000/- per month will be paid to the LRAs. He/she will not be entitled to any DA/HRA/residential accommodation or any other allowance.

4. **Duties and functions /work profile :** LRAs shall function as Research Associate in the Appellate Tribunal for the purpose of legal research mainly, but not limited to, identification, selection, and systematic organization of relevant case laws, citations and judicial pronouncements relevant to specific proceedings, sitting in court during hearing of matters by the Tribunal and noting down the arguments, preparing factual and legal synopsis of the matters listed before the Appellate Tribunal, briefing the Chairman/ Member regarding the case listed for hearing, assisting in preparation of draft judgement if called upon to do so . They shall also be responsible for development, storage and speedy retrieval of such material as per requirement and bunching of similar matters.

5. **Conduct during and after the contract period:**

a. He/she shall maintain utmost secrecy in respect of matters which come to his/her notice by virtue of the assignment and shall ensure that no information, whether in writing or verbal, is leaked out because of his/her action or omission in any manner whatsoever He/She will not disclose any fact which comes to his/her knowledge on account of such official attachment even after completion of terms of assignment unless such disclosure is legally required in discharge of lawful duties.

b. LRAs will not accept any other assignment during his/her term of engagement as such. He/she shall not practice as an Advocate in any Court of Law during the contract period.

c. He/she shall maintain decorum befitting the stature of Appellate Tribunal in the matter of dressing sense and shall be presentable.

d. He/she will not leave headquarter s, i.e. New Delhi, without seeking proper permission in advance.

e. He/she will maintain punctuality in attending to the prescribed office hours and in attending to his/her duties.

f. Since this is a full-time engagement, he/she will not enroll himself / herself in any regular course of any kind during the period of engagement without prior permission.

6. **Period of Contract:** The period of contract, initially, will be for one year, extendable further depending upon the performance and requirement. Engagement on contractual basis will be subject to satisfactory performance and it can be terminated by the Appellate Tribunal, without assigning any reason whatsoever at any time. The short-term contractual assignment shall not confer any right or claim to any regularization or continuance of service.

7. **Selection Procedure:** Shortlisted candidates will be called for interview/personal interaction. Selection will be based on the performance in the interview/personal interaction.

8. He/ She will not be entitled to any kind of regular leave except casual leave on pro-rata basis.

9. He/ She will have the option to give up their assignment by giving one month's written notice. However, the Hon'ble Chairman of the Appellate Tribunal shall have the power to waive the notice period.

10. His/ Her working days and working hours shall be same as are applicable to other serving officers and employees of the Appellate Tribunal. However, depending upon the need and requirement, he/ she will be liable on work beyond office hours and even on Saturdays, Sundays and other holidays without payment of any extra remuneration.

11. The interested and eligible candidates who are willing to serve in the Appellate Tribunal on the above terms and conditions may submit their applications through e-mail at **registrar -atfp@gov.in** or **Speed Post addressed to Registrar, Appellate Tribunal, 4th Floor, A wing, Lok Nayak Bhawan, Khan Market, New Delhi - 110003**. The application should be in the enclosed proforma along with self-attested copies of requisite certificates, in one pdf file.




12. Last date for receipt of application is 24.06.2026, 1700 Hrs. Applications received after last date & time, incomplete, unsigned or not in the prescribed format will not be considered.

13. Candidates will be shortlisted based on the information provided in the proforma. Final Selection would be based on interview /personal interaction which will be conducted on a date which will be specified after short listing of candidates, at New Delhi. During the interview, questions may be asked about the specific provisions of the PML A,2002; PBPT Act, 1998 (As amended in 2016; the provisions of the FEMA,1999 relating to levy of penalties, the SAFEMA, 1976 and Chapter V A of the NDPS Act, 1985 in addition to the relevant provision of the Civil Procedure Code (CPC) and the Bharatiya Nagarik Suraksha Sanhita (BNSS), Bharatiya Sakshya Adhiniyam, 2023 (BSA). Etc. Candidates may also be subjected to tests to evaluate their research skills through use of information technology and otherwise.

14. No TA/DA will be admissible for appearing in the interview /personal interaction. Appellate Tribunal reserves the right to call only shortlisted candidates in the interview/personal interaction and or evolve appropriate selection criteria, within the broad parameters mentioned above.

15. Selected LRAs will be required to bring their own laptop. Internet and other infrastructure support, as deemed fit, will be provided by the Appellate Tribunal to facilitate the work.
